A Resolution Creating an Animal Control Policy on Port Property

Whereas, the Port of Klickitat Commission may formulate all needful regulations for use by tenants, agents, servants, licensees, invitees, suppliers, passengers, customers, shippers, business visitors and members of the general public of any properties or facilities owned and operated by it in accordance with RCW Sections 53.08.220, and

Whereas, the Port of Klickitat Commission wishes to establish an animal control policy governing the behavior of animals and their owners for the safety of others while on Port Property; and

Whereas, the Port of Klickitat Commission reserves the right to revise, replace or abolish such an animal control policy at any time;

NOW, THEREFORE, BE IT RESOLVED:

The following animal control policy is hereby adopted:

“The Port of Klickitat welcomes pets and their owners to enjoy Port property. Our walking trails and open areas are open for your use, and we have made available amenities such as DogiPot animal waste stations to make pet visits to the Port enjoyable for all.

For everyone's safety, and to preserve access and the cleanliness of Port facilities, it is required that pets and their owners observe the following regulations. Your cooperation and assistance in assuring these regulations are observed are greatly appreciated.

Animal Control Regulations for the Port of Klickitat Bingen Point Business Park

ANIMALS MUST:

Always be on leash within the boundaries of Bingen Point Marina Park.

Be kept within sight and voice command and under control of handlers while in all other areas of Port property.

Display tags showing proof of current license and rabies vaccination.

Demonstrate appropriate social interaction; dogs displaying aggressive behavior toward people or other dogs must be leashed and removed from the Port immediately.

HANDLERS MUST:

Pick up and dispose of dog's waste in the appropriate receptacle. DogiPot waste disposal units are provided for handlers' use.

Carry a leash for each dog in your care.

Ensure dogs do not dig. If they do dig, repair any holes created.

Accept responsibility for any damage or injury caused by your dog.

Remain with your dog at all times to supervise, keeping your dog within view and under verbal control at all times.

Bring no more dogs than you can completely control at any one time.

To prevent injury, remove pinch or choke collars when playing off-leash.

For health and safety reasons, do not bring a dog in heat on to Port property. Do not bring a puppy without a complete cycle of vaccinations on to Port property.

Comply with all other Port rules.

Be considerate of Port tenants and neighbors, be respectful of other visitors and protect wildlife.

ENFORCEMENT

Law enforcement personnel and Port of Klickitat Employees have the authority to enforce these rules. Violators are subject to exclusion from Port Property.”

This Resolution shall become effective immediately upon its adoption.
