# Dallesport Industrial Park Water System Rates, Fees, and Charges – 2016

### Standpipe/Hydrant Use

Customers are charged a one-time \$25 (standpipe) or \$75 (hydrant) fee at the time of each application for use. All usage is charged at the rate listed above for 500,001 gallons or more.

There is a minimum invoice amount of \$5. There is no connection or base charge.

#### **Late Payments**

Payments over ten (10) days past due will be assessed a fee of \$10.00.

Payments over forty-five (45) days past due will result in the disconnection of water service.

Overdue balances will be assessed interest of twelve percent (12%) APR.

#### **Rate Increases**

All rates, fees, and other charges described herein will automatically increase by three percent (3%) on the first day of January of each year unless or until a subsequent resolution is adopted wherein one or more new rates, fees, or charges are established.
